



# Cairns RSL Memorial Community Benefit Fund

## General Information

The Cairns RSL Club is committed to the growth of both individuals and Community-based groups as remembrance of the sacrifice and contribution of thousands of Australian men and women in the Defence Forces since Federation and has developed the Cairns RSL Community Benefit Fund from which eligible individuals or organisations may apply for funding.

The fund provides the opportunity for worthy individuals and community-based organisations to seek funding to undertake those aspirations and tasks which they wish to pursue but where additional funding is required to achieve their outcomes. Through this Fund, Cairns RSL Club Ltd is proud to donate, for 2022, a total of up to \$50,000 to eligible individuals and community organisations within the Cairns Regional Council area.

The objective of the Cairns RSL Memorial Community Benefit Fund is to make a difference for successful individual and organisation applicants. Grants may be provided for sporting, academic, artistic or cultural pursuits and to assist recognised community organisations.

1. For Individuals the maximum grant is \$1,500 over a consecutive three (3) year period
2. Community groups must be not-for-profit organisations and the maximum grant is \$6,000 over a consecutive three (3) year period.

Applications open Monday 1<sup>st</sup> August 2022, and must be received by close of business (5:00pm) Friday 02<sup>nd</sup> September 2022. Successful applicants will be notified by mid-September 2022 and should be available for a presentation of funds towards end of September or early October 2022 (date to be advised).



## Supporting Information

The Key Objectives of Cairns RSL Community Benefit Fund are as follows:

- Provide support to the ex-Servicemen and Women's community,
- Provide support to projects or recognised service providers that improve the health or welfare of less advantaged community members,
- Support initiatives that increase and broaden the scope of arts, music, sport and cultural participation and development within the local community,
- Support and encourage local community groups who actively participate in the development of community activities,
- Provide support for the development of life skills within the youth of the community,
- Support and develop innovative responses to identified community issues that impact on family life,
- Support initiatives that increase and broaden the scope of sports participation within the local community,
- Provide support to community groups that deliver local community events,
- See specific terms for each stream and application processes for further information.

All applicants must address these key objectives in their submission and endeavour to satisfy three or more of them.

The allocation of funds is for a specific purpose and must be utilised for the purpose for which it is given and shall not be used for any other purpose

Funds will not be granted to organisations raising funds on behalf of others nor will they be granted to initiatives that receive federal or state funding or businesses or organisations for profit making purposes.



## **General Terms and Conditions for Individual and organisation applications**

1. Individuals and organisations applying for a grant must be located within the Cairns Regional Council boundaries,
2. Individuals or organisations can apply for funds to a maximum as stated above over a consecutive three (3) year period,
3. The successful applicants will be chosen by the three (3) person judging panel nominated by the Cairns RSL Club Ltd,
4. Cairns RSL Club Ltd will provide a cheque for the successful applicants at the Cairns RSL Memorial Community Benefit Fund Presentation late September/early October 2022 (date to be advised). Successful individuals (or their parents/guardians) and up to 2 representatives from the successful organisations will make themselves available for that presentation,
5. The Judging Panel's decision is final, and no correspondence will be entered into,
6. All requested material must be provided, or the application will be considered invalid,
7. Applications and materials will not be returned so applicants are encouraged to use copies and not originals,
8. Judging sheets or other material/aides used by the Judging Panel will not be kept nor distributed to applicants,
9. All applications must be received prior to 5pm 02nd September 2022 - no extensions will be granted,
10. Successful participants will make available to the Cairns RSL Club documentation, photos showing completion / participation of project for the purpose of ongoing promotion of the Community Benefit Fund,
11. Successful and unsuccessful applicants will be notified by mail.



## **Specific Terms and Conditions for Individual Awards**

The individual can apply for a grant on the grounds of sport, academics, or performing arts. They must explain their reasoning behind their applications and provide adequate proof for any statements they make.

1. The Academic applicants must provide proof as to their full-time status at either a school or tertiary institution and proof that their parents live within the Cairns Regional Council boundaries.
2. The individual must state how the money is to be used with quotes attached to the application form. The quotes need to indicate whether the amount is inclusive or exclusive of GST. Only one quote is required per item.
3. The individual must provide at least two (2) independent (non-family member) character statements i.e. from a principal, teacher, coach, instructor etc. supporting the application and these references must be signed by the referee and include contact details.
4. The applicant must disclose if they have applied or intend to apply for or have been successful in obtaining funding from other programs in the past twelve (12) months.
5. Applications must relate to funding of projects that will be finalised in the next twelve (12) months from the date of the application. Applicants agree, by signing the application form, that they will forward proof of expenditure of the Grant Funds to Cairns RSL Club Ltd as soon as possible (Paid invoice/Receipt from Supplier)
6. If the applicant is under the age of eighteen (18) one parent, guardian or carer must sign the application form.

## **Specific Terms and Conditions for Organisation Awards**

Organisations can apply for a grant on the grounds of sport, academics, performing arts or community benefit. They must explain their reasoning behind their applications and provide adequate proof for any statements they make.



1. To be eligible the Community organisation needs to be a not-for-profit organisation or a "Minister Approved" organisation as stipulated by the Queensland Gambling Community Benefit Fund and located within the Cairns Regional Council boundaries. Proof of their 'notfor profit' status (see application) needs to be provided with the application

Ineligible organisations include:

- a. government or semi-government organisations such as hospitals and libraries;
  - b. statutory authorities;
  - c. public and private educational institutions (primary, secondary and tertiary);
  - d. unions and student guilds;
  - e. research foundations and trusts;
  - f. public or private commercial companies;
  - g. organisations that operate and receive funds from gaming;
  - h. religious organisations and groups unless an approved charity; and
  - i. professional association
2. Projects that result in personal benefit or income for an office bearer of the organisation are invalid.
  3. The Committee will consider all projects however deficit funding (to meet debts of an organisation), start-up costs and recurrent costs (including wages and salaries, administration expenses, insurances, rent and consumables) are ineligible projects.
  4. Applications need to provide a community benefit to the people of the Cairns Region and need to be consistent with the key objectives of the Fund.
  5. The organisation must state how the money is to be used with quotes, where relevant, attached to the application form. The quotes need to indicate whether the amount is inclusive or exclusive of GST. Only one quote is required per item.
  6. The applicant must disclose if they have applied or intend to apply for or been successful in obtaining funding from other programs for the project for which they are applying.
  7. Two members of the organisations Committee must sign the application form.



8. Only one application is permitted per organisation. If multiple applications are received they will be considered invalid.
9. Successful applicants are encouraged to acknowledge the grant in an appropriate manner to help increase the awareness of the Fund.
10. Applications must relate to funding of projects that will be finalised in the next twelve (12) months from the date of the application.
